ABLE regularly engages with its various stakeholder groups to elicit general and specific input and feedback. All of our public meetings are open to parents and family members of our students and to interested engagement partners in our community, including representatives from local tribes, civil rights organizations, and other groups that advocate for underserved student groups. Several efforts were made to allow engagement partner input guide the development of the plan. ABLE has regularly held townhall meetings and sent out surveys to elicit input from engagement partners about the services we have provided during campus closures and return to campus. Through this process we learned that communication with parents, continuation of IT, nutrition, and academic services, and increase in SEL / counseling services were important to our constituencies. This previous

input has been built upon and continued to guide ABLE's development of this plan. ABLE's principals hold regular parent meetings, individually and as groups. Through these meetings principals determine the specific concerns and needs of our families, and ask parents questions about how we can improve and increase services at ABLE. ABLE administration has likewise engaged with teachers, counselors, and support staff to ascertain the various needs across departments, programs, and grade levels. ABLE's Academic Council meets regularly to discuss the needs of each department and the needs of the LEA as a whole. The Director of Special Education is a member of the Academic Council and has used these meetings to advocate for the specific needs of special education students. Further, ABLE has engaged with its Charter Advisory Council (CAC) and English Learner Advisory Council (ELAC) regarding the development of this plan. ABLE staff presented information about the ESSER III plan as part of the budget update at the October meetings of the CAC and ELAC, and collected feedback from each group. These groups echoed much of the same input received from other engagement partners: continuation of academic services, services and strategies to accelerate learning, and increased staffing and PD to address SEL needs.

#### A description of how the development of the plan was influenced by community input.

One piece of feedback that ABLE received was the need for additional counseling services. This was echoed by parent groups, teachers, the Academic Council, and Charter Advisory Council. Since returning to campus, there is an exceptionally high need for social emotional and mental health counseling amongst our students, and various stakeholder groups have asked that we increase services. This is addressed through our "staffing increase" action.

Another piece of feedback was the need for additional training for teachers on how to manage students with social emotional needs. ABLE principals and teacher groups were amongst the most outspoken about this need.

Finally, health and safety remains a huge concern of all groups involved. Specifically, there is a consensus that the school doors need to remain open to best serve our students, but there is concern over how to maintain health and safety while students and staff are fully present on campus. Air purifiers, room fans, PPE, and increased cleaning are all called for by groups such as the CAC, parent groups, and teachers.

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before September 30, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 3 – Promising Evidence:** the effectiveness of the practices or programs is supported by one or more well-designed and well-implemented correlational studies (with statistical controls for selection bias).
  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

- Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
- Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

**Note:** A definition of “underserved students” is provided in the Community Engagement section of the instructions.

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
